## **Old Business:**

Discussion on the advertising rates mentioned in both the October 2012 and January 2013 board meeting minutes.

Clarification; the advertising rates are \$15 a quarter (3 months), \$50 annually (12 months) for both the newsletter and webpages for the business card advertisers. The business card advertisers will also have their name and website listed on the Resources page (formerly Favorite Links). The business card and the listing on the Resource page will link to their appropriate website.

The Resource page would have two areas identified; Government and Not-For Profits, and For Profits.

Discussion on the role of the past president. The motion was made; the past officers and board are encouraged to attend and participate in the board meetings as a non-voting members. Discussion on how to increase the membership of NCBCH.
